RECOVERY IN SLOVENIA

EXTRAJUDICIAL RECOVERY

Compensation for claim management costs:

- up to EUR 600.00, EUR 15.00
- over EUR 600.00, EUR 80.00

The fee for successful recovery depends on how much time has passed between the maturity of the debt and the recovery order:

Time between maturity of debt and recovery order	Commission
up to 90 days	5% of total debtor's payment
up to 180 days	7% of total debtor's payment
up to 360 days	10% of total debtor's payment
over 360 days	20% of total debtor's payment
time-barred debts	45% of total debtor's payment

* Commission is charged only in case of recovered debt.
